Noncompliance by members with this agreement may be cause for disciplinary action up to and including dismissal from the Club as outlined in the Club By-laws. RANGE RULES

1.0 POLICIES FOR CONTROL AND OPERATION OF THE LMS RANGE FACILITIES

Overview: The firearm facilities include the following: shotgun range for trap, skeet/5-stand and hand or mechanical throwers; 100 yard, 550 yard (referred to as the "500 yard" for brevity) and pistol house. The Archery range includes the sight-in range and two walking ranges. The walking ranges covers over ³/₄ of a mile and includes multiple distance and elevation shooting challenges.

- **1.1** All policies and regulations in this document will be observed in the operation and use of the Lockheed Martin Space (LMS) range complex. These Rules are binding for each member and are posted at the firearm and archery facilities and reside on the Club's website (www.skylinehfc.org).
- **1.2** LMS range complex operating hours/schedules are "seasonal" and the opening and closing hours will fluctuate quarterly as daylight hours change throughout the year. The range complex is subject to closure, at any time, if a high fire or general safety risk is designated by LMS officials or the Club RSO.
- **1.3** Range opening/closing schedules will be submitted and preapproved quarterly with F&AP. Range schedules will be maintained on the SHFC website.
- **1.4** The Archery Range, where no firearms are permitted, will be open daily during normal (seasonal) operating hours as set forth by LMS F&AP.
- **1.5** The only authorized access to the range is through the range road entrance gate adjacent to Wadsworth approximately 2 miles north of the plant Main Gate. No firearms, ammunition, or archery equipment are allowed in the interior of, or transported through, or stored within vehicles parked at, the LMS campus (accessed from the Main Gate on South Wadsworth Blvd).
- **1.5** No member may access the firearms range for shooting activities unless a SHFC Range Safety Officer (RSO) is present. The RSO will be the first to arrive at the firearm ranges and will sign-in with name, date, and time in the RSO Log located in the RSO shed. The RSO will be responsible



for contacting Facilities & Asset Protection (F&AP) at (303) 977-4646 to notify dispatch that the firearm range is going "hot". The RSO will be the last person to leave the range and will be responsible for calling F&AP Dispatch to notify that the range is "cold". (Note: Hot is when shooting activity has begun; cold is when all shooting activity has completed).

- **1.6** An "acting" RSO shall only provide range safety oversight and shall NOT participate in live-fire activities while acting in an RSO capacity. If a single range is open, the RSO may participate so long as they are able to maintain positive control over that single range. If more than one range is open, the RSO must step back to their full non-shooting duties and supervise range operations. The RSO's sole purpose is range operation safety and oversight.
- **1.7** RSO presence is not required when conducting maintenance or workbond-related activities.
- **1.8** SHFC maintains a "cold approach" to the range. All firearms transported to the range shall be unloaded (no round in the chamber, no magazine in the firearm), and shall comply with the requirements of Rules 1.12 and 4.5 below with respect to insertion of an empty bolt indicator (OBI) and/or empty chamber indicator (ECI). Even if a member has a valid Concealed-Carry Weapon (CCW) permit, firearms must be unloaded before proceeding through the Wadsworth gate/LMS Property.
- **1.9** Upon arrival all members and guests shall directly report to the RSO for sign-in prior to removal of any firearms or ammunition from their vehicles.
 - **1.9.1** Prior to their engagement in Club activities or presence as a spectator, the RSO shall be responsible and accountable to determine, by reference to a database that shall be kept current by the Club Secretary, that all SHFC members, family members and guests have signed and filed with the Club the current form of agreement and release and waiver of liability and competency attestation, in effect for the current fiscal year of the Club.
 - **1.9.2** The RSO shall be responsible and accountable to determine if any person intending to shoot a firearm has provided to the Club Secretary evidence of completion of a hunter or gun safety course, or approved equivalent course certification, before that person is permitted to shoot a firearm on the range. See also Rule 1.9.3 below.

SHFC Range Rules

- **1.9.3** The RSO shall be responsible and accountable to ensure all club members participating in range activities have completed and are adjudicated "compliant" according to the First Advantage Background Screening program.
- **1.9.4** Range Safety brief is mandatory prior to any live-fire range activities, regardless of prior instruction. The RSO shall be responsible and accountable to provide a range safety briefing to all persons present on the range, as participants in Club activities and as spectators, on key safety and operational practices, range rules, policies and procedures. Members of SHFC must have completed and passed the range safety test within the current fiscal year and possess on their person a valid membership identity card.
- **1.9.5** Prior to departure from range, all members and guests must:
 - **1.9.5.1** Remove all magazines / clips / ammo from the firearm prior to moving the firearm from the shooting area to transportation vehicle.
 - 1.9.5.2 Report to the RSO Shack and Sign-Out.
- **1.9.6** The RSO shall be responsible and accountable to document the RSO's presence at the range by name and date and ensure completion of sign-in and sign-out documentation for persons present at Club ranges (other than for workbond or service work). The Club shall retain sign-in and sign-out documentation for no less than three fiscal years.
- **1.10** A SHFC RSO must be present at all times at the shooting facility and a designated Range Officer (RO) must be present on any range that is in use by SHFC members.
 - **1.10.1** Anyone observing an unsafe condition shall call for a "cease-fire". Range activities shall not resume until the designated RO or RSO has resolved any safety issues and ensured that all Range Rules are being followed. Range Rule violations and safety concerns shall be recorded and processed by the RSO.
 - **1.10.2** All shooting activities shall be designed to minimize ricochets. Steel-on-steel live fire is strictly prohibited.



1.10.3 Emergency notification shall be coordinated by the RSO by contacting F&AP 24/7 Security Operations Center at 303-977-4646 to report the situation. In the event of an emergency, a "cease fire" shall be called and all range occupants must remain on the range until authorized to leave by F&AP or RSO.

- 1.10.4 The F&AP Security Operations center shall be immediately notified by phone (303-977-4646) of any injury, security incident, violations of range rules, fire, or any other unsafe condition. LMS (F&AP, Employee Services, Legal, and Risk Management & Insurance) shall be notified of any significant injury or safety infraction occurring on the range facility, with full details of any such event provided in writing not later than 24 hours after the incident. The Club shall comply with all reporting responsibilities contained in the Memorandum of Agreement (MOA) in effect between the Club and Lockheed Martin.
- **1.10.5** Employees of Lockheed Martin Corporation, United Launch Alliance, the U.S. Government and other employers, are subject to disciplinary action under applicable policies and procedures of the employer for any actions or omissions by any such employee during SHFC activities.
- **1.10.6** Drawing and firing from a holster is prohibited. Practicing dry-firing an unloaded pistol from the holster is approved with RSO oversight.
- **1.10.7** The approved method for carrying a holstered pistol is a strong-side, open carry, inside or outside the waistband. Holsters shall be constructed of sturdy material that does not collapse and prevents access to the trigger. Pistols carried in this type of holster will be unloaded and no magazine will be inserted. Any other form of carry is prohibited.
- **1.10.8** Holsters or cases that expose any portion of the firearm (open carry holsters, shotgun "scabbards", etc.) are not considered fully enclosed (see 4.10). Under no circumstances shall firearms be removed from their cases/bags or physically handled during a "cease fire" or cold range, except for shotgun range (see 7.1).
- **1.10.9** Whether as an individual or as a participant in Club shooting activities, shooting of any firearm (pistol, rifle or shotgun) is prohibited if the shooter is changing direction, walking or running. The intent of



this rule is to prohibit firing of firearms other than from a "legs stationary" position or posture. The courses of fire for pistol, rifle and shotgun shooting shall further define this rule.

- **1.11** Non-member attendance and participation rules:
 - **1.11.1** Members may bring no more than TWO guests outside their immediate family ("immediate family" as defined by CRX-534). The SHFC member is responsible for the good behavior and conduct of family and guests at the range, will actively supervise their behavior, and will obtain their compliance with all applicable policies, regulations and procedures while at the range facilities. Each family member and guest will provide approved documentation of formal firearms training and receive a safety/orientation briefing, prior to engaging in any use of the range, as provided in Rule 1.6 above.
 - (a) "Immediate family", per CRX-534, includes your:
 - Parents.
 - Current spouse.
 - Children and their current spouses.
 - Siblings, stepsiblings, half siblings, and their current spouses.
 - Grandparents, step-grandparents, grandchildren, and step-grandchildren.
 - Current spouse's parents (same definition as employee's parents), grandparents, stepgrandparents, children, stepchildren, grandchildren, and step-grandchildren.
 - Current spouse's siblings, stepsiblings, half siblings and their current spouses.
 - **1.11.2** Official SHFC instructors may bring more than two (2) guests outside their immediate family to the range for hunter's safety, firearm safety, and similar instruction, when such classes are approved by the Board of Directors (BOD).
 - **1.11.3** Minors ages 10-17 are only permitted to participate in range activities as part of club-sanctioned, pre-coordinated (with LMS F&AP) and instructor led "special" events, such as hunter's safety courses. Minors shall at all times be accompanied and supervised by their respective adult club member/sponsor. Minors under the age of 10 years old are not permitted to participate in any live-fire activities.



1.12 Group use of Club Ranges and Facilities

- **1.12.1** Groups of non-members, such as hunter education classes and club-sponsored events, may use the range under the supervision of the RSO and a RO appointed by the Club Board of Directors. The Board of Directors will maintain a list of ROs authorized to escort large, non-member groups to the ranges. The size of such groups shall be safely managed by the RSO.
- 1.13 The Club shall comply with Lockheed Martin Cross Function Procedure CRX-251, "Charitable Contributions," including but not limited to provisions prohibiting use of company property (such as the LMS Range Complex and other facilities) and paid employee labor for or by organizations which do not align with Lockheed Martin values, commitment to diversity, or approach to equal opportunity. This includes a prohibition on use of LMS Range Complex and facilities by organizations that discriminate on the basis of race, ethnicity, religion, gender, age, sexual orientation, or other criteria of protected classes as defined by the U.S. Equal Employment Opportunity Commission.
- **1.14** Access to ranges by club members with guests and their immediate family will not require pre-clearance with LMS visitor badges. Before exiting the shooting ranges, members and guests must check out with the RSO.
- 1.15 Firearms are not permitted on Lockheed Martin secured property (see paragraph 1.4 above). Firearms may be placed and padlocked in approved lockers at the designated club location adjacent to the LMS Recreation Facility for storage during working hours. The Club shall document (log) all weapons in and out from the storage lockers. F&AP shall conduct periodic monitoring of the Club's compliance with proper firearm storage practices. A name tagged case is recommended for firearm protection. Firearms shall not be stored overnight. Firearm(s) shall be stored unloaded, bolt/action(s) open and cleared and wherever possible, an Open Bolt Indicator (OBI) or Empty Chamber Indicator (ECI) installed. Violation of this rule shall be grounds for immediate termination of Club membership.
- **1.16** Full automatic or select-fire firearms are not allowed on any LMS ranges at any time except when authorized during law enforcement agency training.
- **1.17** Pets are not allowed on Lockheed Martin property.
- **1.18** Be aware of rattlesnakes on all ranges.



- **1.19** SHFC members, their family members and guests, shall not use, or be under the influence of, alcoholic beverages, drugs or medications that adversely affect coordination, perception, or mental acuity, while handling or shooting firearms on firearm and archery ranges. Use of prescription or other medication not affecting coordination, perception or mental acuity are not affected by this rule.
- **1.20** Members must have their SHFC membership badge available while on the range. Where the shooting activity may be hindered by wearing the badge on a garment, the member shall have their badge readily available for verification.
- **1.21** All organized range activities will be pre-coordinated with the SHFC Board of Directors.
- **1.21** Smoking is not allowed on any of the Ranges, or at any facility used by the SHFC on LMS premises.
- **1.22** Use of ATV's or unlicensed motorcycles is not allowed on any range, range road or LMS property without Board approval.

2.0 RANGE USAGE PROCEDURES, RULES AND REGULATIONS: SHFC AREAS

- **2.1** The SHFC Range Rules were set by the SHFC Board of Directors and shall be strictly adhered to by all members and guests. No deviations to these rules and procedures will be tolerated. Violation of any rule or procedure can be the basis for disciplinary action up to and including expulsion from this Club.
- **2.2** The SHFC Board of Directors requires all members, family of members, and guests to observe all of these rules, policies and procedures and immediately to report any infractions, including but not limited to infractions involving immediate threat to life or limb, to the RSO. In addition to reporting violations to the RSO, members may also report violations, concerns, and suggestions via e-mail to anyone on the Board of Directors. The Board of Directors are listed on the Club Web site.

3.0 RANGE GATE AND ROAD RULES

3.1 All Gates



- **3.1.1** The Main entrance gate adjacent to Wadsworth shall remain locked at all times. When entering or exiting the range, unlock and open the gate then close the gate and relock.
- **3.1.2** Members shall obey the range road closure sign at the main entrance. Members should also consult the club website for news of unplanned road or range closures.
- **3.1.3** Members shall consult the "RSO on Duty" sign inside the Wadsworth gate to verify that the range is open for use by general club membership before proceeding.
- **3.1.4** All gates should be left in the condition in which they were found (if a gate is found closed, it shall be resecured once passed thru; if a gate is opened, assume is shall remain opened). This is in an effort to ensure Horse Club horses are sequestered to the desired pasture at any given time. The horse club may post an occupancy sign to help. If there is a sign on a gate requesting that it be closed, the gate should be closed after passing through it regardless of the state in which the gate was found.
- **3.1.5** Combinations to the locks are not to be given to unauthorized persons based on club and company regulations.

3.2 Road Rules

- **3.2.1** Do not stray from the prepared road surface except at parking areas. The road edges may be soft. During periods of inclement weather, if the road looks bad, consider the ranges closed for practical reasons.
- **3.2.2** Members should assume that during winter months that a four wheel or all-wheel drive vehicle may be required to navigate the range roads.
- **3.2.3** On one lane roads, the vehicle traveling UP hill has the right of way.
- **3.2.4** SHFC shall submit a service request to Facilities (Roads and Grounds) to address needs and requirements for proper maintenance and up-keep of access roads to Club ranges and facilities.

4.0 RANGE SAFETY REGULATIONS: ALL FIREARM RANGES



4.1 There shall always be a Range Safety Officer (RSO) on duty for the overall range. The RSO shall ensure that each member and guest receives a range safety briefing each time they visit the range. In addition, each active range shall have a Range Officer (RO). Each RO will monitor all shooters at that range for safe practices. The first member to arrive at any given range will assume the responsibilities of the RO. The responsibilities of a RO include coordinating range activities with the RSO, calling coordinated cease-fires when necessary and requested, calling for firing to begin or resume, monitoring all members at the range for safe firearm practices and indicating when it is safe to transport firearms (see 4.10.3).

- **4.2** For any group event, there shall be an RSO who will be in charge of the entire event and shall conduct himself / herself accordingly. Prior to the start of any club event, the "RSO" running the event shall give a safety briefing to all participants.
- **4.3** All persons (including observers) must wear eye and hearing protection while shooting is under way on that range. Persons not in the immediate area of the firing line may remove protection, such as when they are in the road way or behind a walled barrier, however, wearing eye protection is strongly recommended at all times.
- **4.4** Firearms shall be pointed muzzle down-range when on the firing line.
- **4.5** During cease fire or when not in use, all firearms shall have the chamber clear, bolt/action open, magazine out, and an empty bolt indicator (OBI) and/or empty chamber indicator (ECI) installed or the equivalent. Four exceptions to this OBI/ECI requirement are break action shotguns, muzzleloaders, holstered semi-automatic pistols, and holstered revolvers. The firearm shall be placed securely at the shooting stations with the muzzle in a safe direction, in the holding racks, in a case, or in a holster. Cased or holstered firearms may have the bolt or equivalent closed.
- **4.6** No shooting is permitted at rocks, target butts/stands, or any other adhoc targets. No shooting of any firearm at steel targets is permitted except during club sponsored silhouette matches. Reactive polymer targets are acceptable. When in doubt ask the RSO on duty. Targets used in authorized club events are pre-coordinated with the Board of Directors.
- **4.7** No persons are allowed on top of the berms (divider dirt mounds).
- **4.8** No firearms shall be handled while persons are down range of the

- **4.9** All members bringing non-members to any range must assume responsibility for the actions of their guests while on LMS property. Members must ensure their guests comply with all SHFC range rules and regulations. This includes responding to all commands of the RSO or the designated RO. The member bringing guests onto the range is also responsible for ensuring that the guest's firearms are unloaded, that the guest's ammunition is compliant with the range rules, and an OBI/ECI is installed and the firearm is handled in a safe manner when approaching the firing line. The RSO and RO in charge will ensure that the guests, as well as other club members, observe all the safety rules and proper shooting etiquette while on the range.
- **4.10** For the 500 yard, 100 yard and Pistol House, fully enclosed cases (see 1.8.8 for definition) and bags (such as range bags and sealed rifle cases) containing unloaded and "safe" firearms per paragraph 4.5 may be transported/stored behind the firing lines (firearm remaining in case/bag) while members are down range during a designated "cease fire" period. Firearms may be transported to the range while the range is "hot", with the permission of the RSO.
 - **4.10.1** Shotgun ranges handling rules differ than mentioned above; see specifics on transporting firearms in section 7.1.
 - **4.10.2** Coordination with the specific range RO is required prior to transporting.
- **4.11** <u>Centerfire Handguns Only:</u> are prohibited from using hollow-point type ammunition on any range. All rimfire handguns are exempt from this rule.
- **4.12** No targets shall be placed beyond the impact area at any range.
- **4.13** Cross-range shooting is prohibited on all ranges.
- **4.14** Shooting directly into dividing berms is prohibited.
- **4.15** Prohibited Ammunition (if in doubt, don't use it!):
 - Hollow point pistol ammunition (except rimfire)
 - Tracer or Incendiary ammunition of any kind
 - Steel shot
 - Some events may have other ammo restrictions and must be clearly identified for



each event (3-Gun, Silhouette, Practical Pistol, etc.)

4.16 Range occupants are required to clean up their expended brass and dispose of it properly into the brass collection cans located in each range building.

5.0 100 YARD, 500 YARD RANGES

- **5.1** A coordinated cease-fire is required on the 100 yard and 500 yard ranges before any person is permitted in the target areas (except as noted in item 5.2 below). Access to the 100 yard target area is further prohibited if any of the following conditions exist:
 - **5.1.1** During firing on the Pistol Range.
 - **5.1.2** Skeet shooting from Stations 6, 7 or 8, as well as 5-stand.
- **5.2** Shooters may advance 25 yards or less on either of the 100 yard or 500 yard ranges without a coordinated cease-fire with the other range to police brass and to place, paste or otherwise repair, replace or remove targets etc. A cease fire is always required at both the respective 100 yard & 500 yard range for any and all advances beyond 25 yards on either range.
- **5.3** Shooters may place, paste, or otherwise repair targets on the 100 yard range, when the targets are placed at 50 yards or less without a coordinated cease-fire with the Pistol Range or the skeet (Shotgun) range. A coordinated ceasefire <u>is always required</u> with the 500 yard range prior to proceeding beyond the 25 yard limit.
- **5.4** It is acceptable to use firearms other than rifles on the 100 and 500 yard ranges. Consult range-mates as a courtesy.
- **5.5** Prior to going to the 100 yard, the shooter must verify for themselves that skeet shooters are not and will not be firing from station 6, 7, 8 or 5-stand. The shooter must also verify that the pistol range is in a cease-fire condition.
- **5.6** Access is permitted to the 500 yard target areas while the pistol range and shotgun range are in use.
- 5.7 Except during club sponsored events, no hand or mechanically thrown



clay bird shooting is allowed on the 100 or 500 yard ranges.

5.8 The Plinking area is established to allow members to have fun shoots with targets that are non-standard. Bowling pins, plastic bottles, and other similar non-glass and non-ceramic items may be used. Clean-up is required and a trashcan has been specifically placed for easy clean-up.

6.0 Pistol Range (Pistol House)

- **6.1** It is permissible to go to the target positions for marking, scoring, replacement or removal of targets up to the 50 yard target location while shooting is under way on the large bore ranges (100 and 500 yard range).
- **6.2** It is permissible to go to the target emplacement at the 25-yard target location while trap or skeet shooting is in progress on the shotgun range.
- **6.3** Do not go beyond the 25 yard target location while skeet shooting or 5-stand is in progress at the shotgun range. Pistol shooters must coordinate a cease-fire.
- **6.4** Always enter/exit the pistol house through the personnel door. Never enter/exit the pistol house from either side.
- **6.5** It is acceptable to use firearms other than pistols in the "Pistol House". Consult range-mates as a courtesy.

7.0 SHOTGUN RANGE

- **7.1** There shall be no firearm handling behind active participants at the shotgun range. This includes transportation of firearms to and from vehicles, handling guns in the rack, etc.
 - **7.1.1** Coordinate with the shotgun range RO prior to transporting firearms.
- **7.2** Constellation Drive from SSNA to DPF MUST BE CLOSED PRIOR TO SHOOTING SKEET. Constellation Drive is barricaded near the entrance to DPF, and at the intersection with Space Park Road (near SSNA parking lot) by gates. Gates must be closed and signs posted. If members are unable to verify closure of Constellation Drive, then F&AP must be called to close and verify gate closure prior to skeet shooting.
- 7.3 Closure of Constellation Drive is not required for trap, 5-stand, or



thrown target shooting. Targets must be thrown straight away from the manual trap firing line.

- **7.4** The Shotgun Range is "shotgun only" i.e., shot shell or shot projectiles only, no centerfire, rimfire, or solid projectiles may be fired at this range.
- **7.5** Recovery of unbroken clay birds from the throwing areas is NOT permitted while other ranges are in use.
- **7.6** Access to the shotgun patterning board is prohibited when shooting is in progress on the skeet / trap / 5-stand range. Only 7 or smaller birdshot shall be used on the patterning board.
- **7.7** Skeet shooters from stations 6, 7 and 8 (as well as 5-stand) shall cease-fire when it is observed that someone has entered the target area on the 100 yard range and/or the 50-yard pistol target area.
- **7.8** The Shotgun range will operate under a general code established by many ranges across the country. Break action shotguns can be handled in the following manner when holding or transporting; breech open, no OBI. The NRA recommended best carry for break action shotguns is action open, trigger assembly on shoulder, gun barrel held by trigger hand, barrel down. Other methods are acceptable, as long as the action is open and barrel discipline is maintained. Additionally, when waiting for a turn to shoot, the shooter may rest a break action shotgun on toe or toe guard as long as the action is open.
- **7.9** When a group is getting ready for a round of shooting, no firearm is to be loaded and the action is to remain open until the shooter is on station and it is his turn to shoot. Any type of shotgun other than a break action will be handled in the following manner: action open before proceeding from rack to shooting station, action open before leaving any station, barrel discipline maintained at all times.
- **7.10** When a round is complete break action shotguns will be cleared, closed and placed in the rack. All other shotguns will be cleared, placed on the rack with the action open and an OBI in place.

8.0 ARCHERY RANGE

8.1 Prior to first usage by club members of the archery range, a basic archery range orientation must be given by an approved club archery range lead.



- **8.2** GATES: Please follow the rules in the sections on access gates. These are the rules as specified by the horse club, with whom we share the land.
- **8.3** Drive on established roads only.
- **8.4** No firearms are allowed.
- **8.5** Please pick up trash and any torn pieces of targets when found.
- **8.6** Do not use broadheads on any bale, 3D, or pillow targets. Broadheads can only be used a designated broadhead target at the sight-in range.
- **8.7** Follow the target sequence when walking on the range.
- **8.8** When hunting for arrows behind targets, mark the target with the bow left leaning against the target, or by leaving it at the shooting stake.
- **8.9** All observers must be behind the archers. All archers shall verify that members of their group and other range users are in a safe location.
- **8.10** Only shoot arrows at established target locations on the range and assure the firing lane is clear.
- **8.11** Anyone utilizing the tree stand for target practice must use appropriate safety gear, including a harness, maximum 2-3 foot lanyard and a pull-up line for the bow. All attached tree stand hardware must be inspected prior to use. A buddy system is required for tree stand use. The use of body-belts in lieu of a body-harness is expressly forbidden.

9.0 RANGE STATUS FLAGS

- **9.1** Red Range Status Flags are to be placed in their holders by the RO outside of each range (55
- 0, 100, pistol and shotgun) to identify when that specific range is in use. The Flag/Flags shall remain up whenever that range or ranges are in use.
- **9.2** In addition to the Range Status Flags, when the range is in operation the red flashing lights at the 100 yard/ Pistol House/ Shotgun Range must be turned on, via the control switch inside the Pistol House.

10.0 PERIODIC OUTSIDE RANGE SAFETY REVIEW

10.1 No less often than every five years, beginning in 2019, the Club shall



engage an outside expert or experts, certified by the National Rifle Association or organization with equivalent expertise, who shall be tasked to conduct a thorough 'best practices' review of the SHFC firearms ranges, range rules, and safety practices and procedures. The expert shall provide a written report with specific findings and recommendations for improvement. A copy of the report shall be provided to LMS Human Resources, F&AP, ESH and Legal.

- **10.2** To the extent feasible and practical, the outside expert shall be requested to incorporate a checklist into his/her report, demonstrating compliance or noncompliance by the Club with National Rifle Association standards and best practices.
- **10.3** The Club shall implement all feasible and practical recommendations and provide its rationale to LMS should the Club disapprove any specific recommendations for improvement.

11.0 ENVIRONMENTAL COMPLIANCE PROCEDURES

- **11.1** The Club shall develop a lead management program and submit the plan to ESH for approval. This plan shall be kept current and compliant with all requirements of ESH. The current lead management plan is attached and incorporated by reference in these Rules as Appendix "A".
- **11.2** The Club shall develop a solid hazardous waste management program and protocol, and submit the plan to ESH for approval. This plan shall be kept current and compliant with all requirements of ESH. The current hazardous waste management plan is attached and incorporated by reference in these Rules as Appendix "B".
- **11.3** The Club shall coordinate with ESH and obtain written ESH approval prior to digging or excavating soil.

12.0 SILHOUETTE SHOOTING

- **12.1** Silhouettes will only be used for club sponsored events and a dedicated RO will attend, supervise, and provide a safety briefing prior to all club silhouette events.
- **12.2** Any shooting of steel targets at non club sponsored events is strictly prohibited (At no time will there be shooting of any steel targets or silhouettes on the pistol and/or 100-yard ranges.
- **12.3** The silhouettes will be stored under lock and key and will only be



accessed by the committee chairperson or alternate.

- **12.4** Shooting of silhouettes with 22's is only allowed at yardages further than 40 yards; with lead bullets and are only allowed on the 200-yard range. Only 22 caliber rimfire is allowed to be used on 22 silhouettes.
- **12.5** Shooting of centerfire silhouettes is allowed only with soft point jacketed bullets or lead bullet ammunition at yardages no closer than 200 yards and are only allowed on the 500-yard ranges. FMJ is strictly prohibited for use on any silhouettes. The RO will check participant ammo prior to any event.
- **12.6** No other metal targets other than approved club owned silhouettes (AR500 chickens, AR500 turkeys, AR500 pigs and AR500 rams) are allowed for use at the range.
